- **Legitimate interests** – where processing is necessary for our business interests and does not override your rights

## 6. Cookies

Cookies may be used to:

- Improve website functionality
- Remember user preferences

## 7. Sharing Your Data

We do not sell, rent, or trade your personal data.

We may share your data with trusted third parties where necessary, including:
